I progressed my Building Control career within different Local Authorities including Bournemouth and New Forest Councils.

During my 29 years within Local Government Building Control departments, I dealt with numerous enforcement cases relating to unauthorised building work, dangerous structures and licencing issues. The Dangerous Structure call-outs ranged from loose fall roof tiles, to a large hotel fire, to a trapped person within a partial collapsed dwelling. I was an active member of Dorset Building Control Technical Group and was a member of the Safety Advisory Group for AFC Bournemouth.

I furthered my Building Control career within the private sector and gained greater experiences with larger, more complex developments and within different sectors of the Construction Industry. I am client focused and greatly value the importance of collaborative working with both the design and construction teams to ensure full compliance with the requirements of The Building Regulations is achieved.
